1. GENERAL

1.1 The current Raja Isteri Pengiran Anak Saleha (RIPAS) Hospital's vehicle fleet includes as detailed in Appendix A;

- 1.2 The Ministry of Health, in its continuous effort to improve the efficiency and reliability of its vehicle fleet operations, invites experienced and qualified contractors to participate in this tender for the **Supply and Installation of Maintenance-Free (MF) Vehicle Batteries** for Raja Isteri Pengiran Anak Saleha (RIPAS) Hospital's Vehicles over a period of **two (2) years.**
- 1.3 This contract aims to engage a service provider capable of delivering reliable, timely and highquality battery replacement services for RIPAS Hospital's vehicles.
- 1.4 Orders for batteries will be placed periodically throughout the contract period based on actual requirements. No minimum quantity is guaranteed, and all orders will be issued directly by the Officer in Charge or their designate

- 1.5 The rates for the supply and installation of batteries will follow a **fixed schedule of rates** provided in the **quotation attached in Section 3 (Schedule A).** Tenderers are to refer to this appendix for the detailed pricing, battery types and specifications.
- 1.6 Tenderers must submit **technical specifications**, **product catalogues or literature** with their proposal to validate the offered products.
- 1.7 For reference, a list of **RIPAS Hospital vehicles and their corresponding battery specifications** is attached in **Appendix A.** Contractors are required to refer to this appendix to ensure battery compatibility with each vehicle.

2. SCOPE OF WORK

- 2.1 This procurement is necessary to support the continuous and reliable operation of RIPAS Hospital's vehicle fleet, including ambulances and service vehicles. The use of Maintenance Free (MF) batteries is intended to reduce routine maintenance, minimize vehicle downtime, and ensure the availability of vehicles for RIPAS Hospital operations.
- 2.2 The Contractor shall provide **supply and installation services** for Maintenance-Free (MF) Vehicle batteries to RIPAS Hospital for a period of **two (2) years.**
- 2.3 The scope of work includes, but is not limited to, the following:

2.3.1 Supply of Batteries;

- 2.3.1.1 Supply new, freshly manufactured batteries less than one (01) year old at the time of delivery).
- 2.3.1.2 Ensure batteries match the specifications in **Appendix A** and are compatible with the manufacturer's recommendation for each vehicle.
- 2.3.1.3 Maintain sufficient stock at the Contractor's facility to ensure timely response to all requests.
- 2.3.1.4 Any other accessories required for battery installations shall be replaced with new items. These shall be treated as Provisional Items and priced separately

2.3.2 Installation Services

- 2.3.2.1 Carry out installation within **3 hours** after receiving a formal notification from the Officer in Charge.
- 2.3.2.2 Provide **on-site installation**, including at breakdown sites or any other location as instructed.
- 2.3.2.3 The rate for battery installation shall be inclusive of necessary services such as cleaning of terminals, crimping, and the use of all required consumables

2.3.3 Inspection and Troubleshooting

- 2.3.3.1 Inspect and confirm that the **vehicle's charging system is in good working condition** before battery replacement.
- 2.3.3.2 If faults are found, immediately report to the Officer in Charge and **hold off battery replacement** until further instructions are given.

2.3.4 **Post-Installation**

- 2.3.4.1 Ensure proper terminal connection, voltage checks, and secure fitting of the new battery.
- 2.3.4.2 Return all used/replaced batteries to the **Unit Kenderaan dan Pemeliharaan, RIPAS Hospital** for official recording and disposal.
- 2.3.4.3 Submit a brief service report indicating the work done, vehicle details, battery specifications, and date of installation for review and approval by the Officer in Charge.

3. TECHNICAL REQUIREMENTS

- 3.1 All batteries supplied under this contract shall be;
 - 3.1.2 Maintenance-Free (MF) sealed batteries do not require refilling of electrolyte.
 - 3.1.3 Freshly manufactured not more than one (1) year old at the time of delivery.
 - 3.1.4 Covered by a minimum six (6) month warranty from the date of installation
- 3.2 The contractor must refer to the **vehicle's original manual** or specifications to ensure compatibility.
- 3.3 Only batteries of **reputable and high-quality brands** shall be accepted. The following brands are **recommended such as**; Amaron, Varta, Bosch, Trane, Deka, Atlas Visca, or any equivalent brand.
- 3.4 Batteries found to be defective during the warranty period must be **replaced at no additional cost**.

4 PROVISIONAL ITEMS AND DEFECTIVE PARTS SUPPLY

- 4.1 The Contactor shall, upon instruction by the Officer in Charge (OIC), supply and install any additional accessories or defective parts related to the battery system as required
- 4.2 These provisional items/services shall only be executed with prior written instruction from the OIC
- 4.3 Only the quantities as ordered by the (OIC) shall be supplied or installed.
- 4.4 Any parts replaced under this provision shall carry a **minimum warranty of six (6)** -**months** from the date of installation

5 SUBMISSION OF PROPOSAL

5.1 The proposal should include the following documents;

Vehicles for a period of Two (2) years"

- 5.1.2 **Technical Proposal**: This should contain detailed information regarding the contractor's ability to fulfill the requirements of the scope of work, including technical specifications of the batteries being offered, compliance with warranty requirements, and the contractor's experience and qualifications.
- 5.1.3 **Product Catalogues or Technical Literature:** Tenderers are required to submit product catalogues, technical sheets, or literature to substantiate the technical details provided in the proposal, including battery, specifications, warranty conditions, and brand offerings.
- 5.2 The proposal should be submitted in a sealed envelope/package, clearly marked with the tender reference number and title: **"Tender for Supply and Install Batteries for Raja Isteri Pengiran Anak Salleh Hospital's**

6 CONTRACT DURATION

- 6.1 The successful Tenderer shall be awarded a contract for a duration of **two (2) years** commencing from the date of the official Letter of Acceptance issued by RIPAS, Ministry of Health.
- 6.2 The Ministry of Health reserves the right to extend or terminate the contract earlier, subject to performance review and mutual agreement,

7 DELIVERY & RESPONSE TIME

- 7.1 The Contractor shall be required to supply and install the batteries **within 3 hour** upon a receipt of a request or notification from the Officer in Charge or their authorized representative
- 7.2 In the event of an emergency, the Contractor shall be required to provide battery supply and installation services promptly, outside of normal working hours, as instructed by the Officer in Charge or their authorized representative.
- 7.3 Should the Contractor fail to deliver or install within the specified timeframe, the Ministry of Health reserves the right to appoint an alternative supplier and recover any cost differences incurred.

8 WARRANTY TERMS

- 8.1 All newly installed batteries must come with a **minimum warranty of six (6) months** from the date of installation.
- 8.2 Provisional items, such as defective parts, shall be covered with a **minimum of two (2) months** warranty upon replacement or installation.
- 8.3 Any battery or part found to be defective within the warranty period must be replaced at **no additional cost**, including installation and transportation/towing.

9 PAYMENT TERMS

9.1 Payment shall be made by the Government of His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam upon satisfactory completion of the supply and installation of the Maintenance Free (MF) Battery(ies), and upon submission of a valid invoice and approved service report by the Officer in Charge. All claims shall be addressed to:

- 9.2 The Contractor shall ensure that all invoices include the relevant vehicle details, battery specifications, date of installation, and any other necessary references as required by the RIPAS Hospital
- 9.3 No advance payment shall be made. Payment shall only be processed after the full delivery and proper installation of the battery(ies), and upon verification by the authorized Hospital representative.

10 CONTRACT TERMINATION

- 10.1 The Ministry of Health reserves the right to terminate the contract in whole or in part at any time during the contract period if the Contractor:
 - 10.1.1 Fails to meet the required standards of performance as assessed through periodic service reviews or inspections;

- 10.1.2 Repeatedly delivers unsatisfactory workmanship or delayed responses to service requests;
- 10.1.3 Supplies non-original or non-OEM parts in violation of the contract terms;
- 10.1.4 Fails to comply with the agreed technical specifications, warranty terms, or instructions from the Officer in Charge.
- 10.2 Prior to termination, the Contractor shall be formally notified in writing a granted a reasonable period to rectify any performance-related shortcomings. Failure to resolve such issues within the specified timeframe shall results in contract termination without further obligation by the Ministry.
- 10.3 In the event of termination, any unfulfilled services of undelivered parts may be reassigned to an alternative contractor at the existing contractor's cost and risk.
